These emerging leaders spend a year of modestly paid public service partnering with community organizations and public schools to teach children about food and nutrition, give them opportunities for hands-on engagement with healthy food in school gardens, and provide them with regular daily access to farm-fresh food through school meals. In the process, our service members help combat obesity and diet-related disease, build their own careers, and cultivate a more just, sustainable and healthful food system.
